A. Call to order – The meeting was called to order at 6:35pm by Dick Betway.

B. Submission of June meeting Minutes - Cindy Parkhurst

1. The June 21, 2016 meeting Minutes were reviewed. After discussion, the Minutes were approved.

C. Financial Report

- 1. Board members received and reviewed a copy of the June month-end receivables and disbursements ledgers. The Annual Budget was also reviewed.
- 2. There is one unit (#203) that is 2-3 months behind on Association Dues. The Board to initiate small claims proceedings.
- 3. After discussion, the Financial Report was approved.

D. Old Business

- Regarding the sprinkler issues reported last month: Apex was called out for repairs. They walked through the entire system and replaced seven rotor heads, rewired one of the zones, and redirected a sprinkler away from a Co-owner's car, per Co-owner request.
- 2. The sewer system pumps were replaced following a power surge. The Board is continuing to pursue an insurance claim.
 - An electrician was called out to test our surge protector. The electrician found that there is power going to the surge protector, but was unable to determine whether it's functioning properly. Given the age of the surge protector, the Board will look into replacing it with a newer, more appropriate model.
- 3. The missing shingles on the south side peak of 2445 have been replaced.

4. In April 2016, a Board member noted that the north side soffit of 2465 needed to

be sealed. The Board has since found other problem areas, and has accepted the

bid of Lively Home Improvement for repairs and sealing.

E. New Business

1. The Board received two written complaints regarding an incident with a dog that

occurred in the early morning of July 5th 2016. The written complaints were from

the Co-owner and his new tenant. One of the dogs was taken for a mandatory 10

day quarantine, the other was treated for several injuries.

There was much discussion as the Board reviewed both complaints. The Board

has been in contact with Animal Control, and is awaiting a copy of the police

report in an effort to determine the correct course of action.

2. With the resignation of Board President Steve Laskey, Vice President Dick

Betway has assumed the position of President. This left a vacancy in the Vice

President position. Dave Socall was nominated, and seconded for the position of

Vice President, which was accepted by a 5-0 vote.

3. We've recently experienced two power outages in our community, and we're

happy to report that our new generator effectively kept our sewer system

functioning. The Board asks that residents reduce water usage as much as

possible during power outages to minimize stress on the system.

4. A Co-owner reported a blocked downspout at the northeast entrance of 2465. The

Board to investigate.
