B. Submission of September meeting Minutes - Cindy Parkhurst

- 1. Some residents have reported an issue with their WeatherGard windows being misaligned and/or not being able to lock them. - 2. The gutter cleaning project has been completed. However, a Board member noted a possible issue with a gutter guard. The Board to investigate.
- 3. The sprinkler system has been winterized. A Board member noted that the dock and building water systems needs to be winterized. The Board approved a bid from Doug Socall for \$125.
- 4. A Co-owner reported a problem with over-hanging trees at the carports, which could have potentially clogged up the gutters. The Board would like to thank Patty Goodish for bringing this to our attention.
- 5. The Board received a complaint from our neighbors to the north (Riverside Condos) that the runoff from our carport drainage system is flooding their parking lot. It was noted that their drains could possibly be plugged. The Board to investigate in the Spring.
